In recent weeks, so-called <u>"innovative solutions"</u> for migration have gained renewed strong political attention from Member States, with different proposals ranging from return hubs in third countries, revising the Return Directive to expanding the use of "safe country" concept. Meanwhile the Italy-Albania protocol became operational and has immediately faced legal and practical hurdles.

The recent "blueprint" <u>deals</u> with Tunisia, Egypt, Mauritania, and Lebanon illustrate how migration has become a pivotal focus of the EU's relationships with Mediterranean partners.

These agreements, often brokered with substantial influence from a few Member States in concertation with the European Commission, have sometimes bypassed the EEAS and the European Parliament and signal a structural shift in the EU's foreign policy where short-term considerations are taking primacy over long-term objectives.

Join us in this event organised by EuroMed Rights in collaboration with the Greens/EFA group where we'll discuss with experts and activists from the region the situation on the ground, the strategies that can be leveraged to oppose these trends, and what role can the European Parliament and civil society play.
